	ACTION	EXPLANATION
	Adopt an appropriate mindset	<ul style="list-style-type: none"> <li>• It is an investigation, not a conversation.</li> <li>• The communication strategies on this checklist are not intuitive—be prepared to fight human nature.</li> </ul>
	Establish credibility and create a favorable impression of the organization.	<ul style="list-style-type: none"> <li>• Be cordial, polite, and businesslike.</li> <li>• Remember, you know your business better than anyone else.</li> </ul>
	Document interactions with auditors.	<ul style="list-style-type: none"> <li>• Identify a notetaker who will be present for interviews.</li> <li>• Record all questions/answers/statements.</li> <li>• Note action items required of hospice or promised by auditors.</li> </ul>
	Make sure you understand the question.	<ul style="list-style-type: none"> <li>• Listen to the questions fully.</li> <li>• Don't assume you know what they are asking.</li> <li>• If you do not understand a question, ask for clarification—"question the questioner."</li> </ul>
	Satisfy the questioner	<ul style="list-style-type: none"> <li>• Provide accurate information that is responsive to the question.</li> </ul>

	ACTION	EXPLANATION
	Provide a focused response	<ul style="list-style-type: none"> <li>• Do not volunteer information that is not responsive.</li> <li>• Resist the temptation to “fill the silence” with information that was not requested.</li> <li>• Scope of answer should match scope of question—broad/broad; narrow/narrow</li> </ul>
	Avoid being misinterpreted.	<ul style="list-style-type: none"> <li>• If questions cannot accurately be answered in one word, provide a sufficient explanation.</li> <li>– A response of “Yes, however...” can be effective in turning a negative into a positive.</li> </ul>
	Don’t go “out on a limb.”	<ul style="list-style-type: none"> <li>• Understand the limits of your knowledge.</li> <li>– “I don’t know” is an appropriate response if it is accurate.</li> <li>• Do not guess at an answer, even if you would preface the response with “This is just a guess, but...” Instead, the appropriate answer is likely “I don’t know.”</li> <li>• Be cautious about offering opinions.</li> <li>– Consider whether you are qualified to provide an opinion, especially about medical issues.</li> <li>– Consider whether you have enough information to provide an informed opinion.</li> </ul>
