Don is currently chair of the Wisconsin Elections Commission, the state agency that oversees elections in Wisconsin. This is Don's second stint on the Elections Commission. He previously served as a member and chair the State of Wisconsin Elections Board, a predecessor agency to the Elections Commission.
