

Privacy Policy

At Reinhart Boerner Van Deuren, we care deeply about privacy.

Reinhart Boerner Van Deuren s.c. ("Reinhart", "we" or "us") is committed to safeguarding your privacy while providing you relevant content that is valuable to you and your business, so we have taken measures to make it clear how your information is collected and used by Reinhart.

By using this website, including by providing your personal information, you consent and agree to the terms specified in this Policy. This Privacy Policy is intended to assist you to understand how we collect, use, disclose and protect the personal information you elect to provide us and to enable you to make an informed decision about using our website.

What Personal Data Is Collected

We collect personal data that you provide whenever you communicate with us through this website, emails and at Reinhart events. We may also collect or receive personal information from third-party websites and services (e.g. LinkedIn). Certain areas and services on the website may ask you to provide personal information, including by logging in or registering. This may include providing personal information collected to register for Reinhart's client alerts or to register for events (e.g., name, organization, phone number, email address, address), or to apply for career opportunities with Reinhart (e.g., employment and educational background, and other relevant identifying information). If you register or complete forms on any portion of the website or in tangible form, you may subsequently receive information about client alerts, events, or other materials or activities.

We also collect automatically as the result of your use of our website and interaction with forms found on our website, in emails or at Reinhart sponsored events. This information includes but is not limited to:

• Contact Information: the Internet Protocol (IP) address enables us to determine the device from which you are accessing the Reinhart websites, the operating system you are running, the screen resolution of the device, the country and city from which you are accessing the website, your language preference, web browser version, and other details during your visit.



- Usage Information: the specific actions you take on the website, including the pages you visit or click on, the date and time of your visit, the frequency and duration of your visit(s), and the search terms you use to navigate the website.
- Referral Information: if you arrive on the website from an external source (such as a link in an email, a link published on social media, etc.), we record the details about the source that directed you to our website.

How We Use and Basis for Collecting Personal Data

Reinhart uses your personal information and information obtained for our own business, educational, social, and recruiting activities to personalize your experience and to improve the performance of our website. We may use your personal information to:

- Communicate with you;
- · Provide you publications, products, services and marketing materials; and
- Notify you of events.

We collect information that allows us to determine the success of marketing campaigns and our website, which we use to refine our offering to better service our clients and interested third parties.

We collect and process the majority of your personal information when you voluntarily provide it or otherwise indicate your consent. Any other processing is performed (a) when we have a legitimate interest in processing your personal data, (b) pursuant to a contract between you and us, or (c) if we are legally obligated.

Cookies & Technologies We Rely Upon

You can navigate the majority of the website without giving personal information. However, Reinhart and its service providers use cookies and other commonly used automatic data collection technologies, such as web beacons, both session and persistent on our website and e-marketing. Unlike session cookies, which expire when you close your browser, persistent cookies remain on your hard drive. Cookies are small text files placed on the device you use to access our website that allow us to collect data to improve the website and user experience. Cookies allow us, among other things, to recognize repeat users, store user preferences and settings, provide visitors with personalized content, and remember information entered in forms in future visits. 1. Introduction

The purpose of this Cookie Policy is to describe how Reinhart Boerner Van Deuren s.c. ("Reinhart", "we" or "us") collects, uses and shares cookies through our website (the "Site"). 2. What are cookies?

A cookie is a small amount of data that is sent to your computer when you visit a website. When you visit the website again, the cookie allows that site to recognize your browser. We use third-party tools and applications such as HubSpot and Hotjar to analyze our Site traffic and improve our user interaction. These third-parties also use cookies. Similarly, we use Google Analytics to collect information about how the Site is used. Google Analytics services involve the use of cookies that collect information such as your IP address or other identifiers, browser information and information about the content you view and interact with to record how you use our Site. Google Analytics uses cookies to customize the advertisements you see to ensure they are relevant to you. These analytics help us to know how many users we have, which parts of our Site are most popular, what browsers are used, the country or region where our users are located and the demographics and interests of our users.
