

## Reinhart's Cameli Honored as Citizen of the Year by Justinian Society of Wisconsin

MILWAUKEE – [Mark A. Cameli](#), shareholder with [Reinhart Boerner Van Deuren s.c.](#) (Reinhart), was honored as "Citizen of the Year" on Friday, October 12, at the Nineteenth Annual Columbus Day Awards Banquet, sponsored by the Justinian Society of Wisconsin. Cameli is the organization's past president and serves on its Board of Directors.

A shareholder in Reinhart's Litigation Practice and chair of the firm's White Collar Litigation and Corporate Compliance team, Cameli is a member of Reinhart's Board of Directors and leads the firm's Diversity Committee. And, in a way, they deferred those dreams for their children—my parents—who, in turn, did the same for me and my siblings. And I shall never forget that."

At each annual banquet, the Justinians also present awards for the Jurist of the Year and Italian of the Year. This year's recipients were Wisconsin State Judge Marshall Murray and world-renowned restaurateur Sanford D'Amato. The Society uses the banquet as its primary fundraiser for the scholarship it presents each year to a Marquette University Law School student.
