

## Reinhart's Narrai Receives American Advertising Federation Honor

MILWAUKEE – <u>Andy Narrai</u>, Director of Marketing at <u>Reinhart Boerner Van Deuren s.c.</u> (Reinhart), has received the <u>American Advertising Federation (AAF)</u> Barton A. Cummings Gold Medal Award.

The annual award recognizes distinguished volunteer service to the advertising industry through the AAF. Narrai accepted the award at the AAF's ADMERICA! national conference in Boca Raton, Florida on May 29.

The award was presented by Ann Iverson, principal of Creating Selling Opportunities and Bart Cummings' daughter.
