## Matters

- Won a record setting jury verdict on behalf of an industry-leading manufacturer of professional grade power tools in a patent infringement case that resulted in a \$31 million judgment.
- Successfully defended six of twenty defendants accused of forming an antitrust cartel to boycott and discourage use of plaintiffs' patented technology; all claims against them were dismissed with prejudice.
- Won dismissal (affirmed on appeal) of nationwide antitrust, extortion and unfair compensation claims under federal and California law
- Won an arbitration award rejecting trade secret claims by a former supplier to a major Wisconsin manufacturer
- Won dismissal (affirmed on appeal) of claims that a bank negligently facilitated a Ponzi scheme that allegedly stole more than \$100 million of investor funds
- Won dismissal of litigation that alleged monopolization and attempted monopolization of the vision care insurance market
- Won a no-liability decision for a motor vehicle manufacturer wrongfully accused of misappropriating trade secrets allegedly worth \$250 million
- Won summary judgment for a cleaning products manufacturer wrongfully sued by eight dealers who sought more than \$200 million in damages and injunctive relief based on a long list of legal theories ranging from antitrust and unfair competition to bad faith, tortious interference, breach of contract and promissory estoppel

- Won a no-liability decision for a large cocoa products manufacturer wrongfully accused of illegally terminating its exclusive Mexican distributor
- Won dismissal of a class action complaint alleging the County of Milwaukee unconstitutionally used \$200 million of surplus pension assets to fund new pension benefits for county workers.
